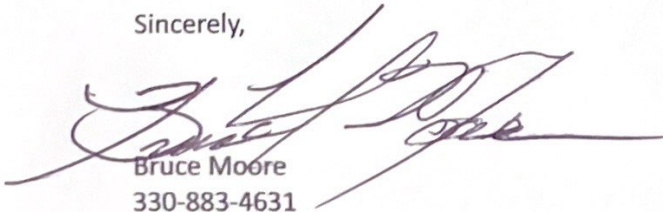
I have been actively involved with the Charter Review Committee for the past two years.
